APPLICATIONS: Complete the application and return it with your payment by September 1, 2017. No spaces will be reserved until we have received the application and the fees. Checks to be made out to Dayton Valley Days and mailed to P.O. Box 1758 Dayton NV 89403 along with your application. Applications will be processed on a first come first placed basis. If you have a preference for your space please note it on your application. We **cannot** guarantee you will get that space but we will do our best to fill all requests. No refunds will be given due to weather related issues.

ELECTRICITY: Electricity is **not available** and **generators** are allowed in specific spaces only – If you are applying to use a generator you must request it under **SPECIAL NEEDS** on your application. Generator spaces are on a first come first placed basis and must be the “quiet” type.

CONFIRMATION: Confirmations will be via e-mail or telephone. If you do not receive one please give us a call at 775-301-9567.

BOOTH SPACES: All booth spaces are outdoors. Vendors need to provide their own tables. Tables must be covered. Shade structures are recommended. Vendors should prepare for windy afternoons – canopy stakes or weights are strongly advised. We will have some weights available for rent if needed. There are no rain dates – No refunds will be made for weather related issues.

NON-PROFIT ORGANIZATIONS: You **must supply** a copy of of your non-profit status with your application.

FOOD VENDORS: Food vendors **must** have a health permit from the Nevada State Health Department, including those handing out samples. Even if you have a permanent one you will need a temporary one for this event. Please list all foods you plan to sell on your application. **Vendors cooking over open flames must cook away from their canopy.**

Vendors **may NOT** sell or distribute alcoholic beverages, unless granted special permission by the Dayton Valley Days Committee.

GLASS CONTAINERS ARE PROHIBITED FOR SAFETY REASONS.

SET-UP TIME: Set-up starts at **12 NOON on Friday** or **before 8am on Saturday**. Check in at the **registration booth** located at the corner of 3rd Street and Pike Street. Your space will be assigned to you and you will receive your tax and information packet. **All vehicles must be out of the festival area by 8AM each morning** and vendors must park in the designated vendor parking area. No parking on Main Street, Gate Street or in business parking lots.

EVENT TIMES: Saturday, 8:30 AM to 5:00 PM and Sunday, 8:30 AM – 3:00 PM

SECURITY will be provided Friday and Saturday from 8PM-6AM. Dayton Valley Days, Inc. will not be liable for any lost, damaged or missing goods or equipment. All Booth merchandise must be covered and secured at night.

Vendors must be present both days.

Vendors must provide an item for our Silent Auction. It should be dropped off at the Community Center by 9 AM Saturday morning.

No Vendor may sell raffle tickets or hand out flyers, literature or samples outside of their booth. Only food vendors may sell food and drinks and food or drinks are not to be given away.

All Net Proceeds from the silent auction, and booth spaces, and drink wagon are used to provide for the preservation for Old Town Dayton and to assist local service organizations.

Tear Down, Check Out, and Clean Up: **DO NOT TEAR DOWN UNTIL** 3 PM Sunday, do not block the street, clean up your booth space, place all trash in proper receptacles and turn in your sales tax forms and money.
